Since its inception in 1993, the Registry has served to elevate professional standards and provide recognition for specialists in group psychotherapy. In a competitive and demanding practice environment, certification is an important way for group therapists to distinguish themselves from other clinicians. To earn the CGP credential, candidates must satisfy clinical experience and education requirements in group psychotherapy as well as hold an active state license and/or active clinical membership/certification status with designated professional organizations and current professional liability insurance. Once earned, the certification must be renewed every two years by participating in 18 hours of continuing education in group psychotherapy, insuring ongoing professional development.

“The CGP designation is a symbol of competency and accomplishment,” said Sherrie Smith, CSW-R, CGP, FAGPA, Chairwoman of the Registry. “These individuals should be commended for their commitment to the group field, and their drive to pursue standards that make them effective group leaders, providing quality mental health services to the public-at-large.”

Many organizations, such as the Social Work Certification Committee of the Veterans Health Administration, use the CGP as a qualifying credential for referrals, job placement and promotion as it verifies experience, supervision and continuing education.

The Registry also provides an online searchable directory of CGPs at www.agpa.org which is available to the public for referral purposes and is searchable by city/state, zip code and/or type of group. The search options help a person find a therapist(s) in their area who works with the appropriate population (multiple referrals are often available). A confidential contact can then be made by telephone or e-mail directly to the therapist(s).

The site also contains general information for the consumer who is interested in joining a group, including what happens in a group, who can benefit, and answers to other frequently asked questions. This information is also available in a printed pamphlet "Group Works" available free of charge through the Association office.
