“PRACTICE GUIDELINES FOR GROUP PSYCHOTHERAPY”**

NEW YORK, June 6, 2007 — The American Group Psychotherapy Association (AGPA) announced the release of “Practice Guidelines for Group Psychotherapy,” a document which addresses areas considered essential to the successful practice of group psychotherapy.

Authored by the Science to Service Task Force, a blue ribbon panel of clinical and research experts in the field of group psychotherapy chaired by Joseph Kobos, Ph.D., ABPP, CGP, FAGPA and Melyn Leszcz, M.D., FRCPC, CGP, the guidelines are a cross-theoretical guide to developing and leading psychotherapy groups. Supported by clinical research, and developed through an expert consensus process, they are a practical resource for mental health professionals, and also serve the public-at-large by providing consumers with valuable information on the practice of group psychotherapy.

“These guidelines are a valuable new resource for the field of group psychotherapy and the client base it serves,” said Elizabeth Knight, M.S.W., CGP, FAGPA, AGPA President. “They are a concise guide to the basic tenets of practice, with a client-centered approach that maintains clinical integrity and creativity.”
