## AGPA CONNECT ANNUAL GROUP-BASED MENTAL HEALTH INTERVENTIONS TRAINING TO BE HELD IN LOS ANGELES, FEBRUARY 25 – MARCH 2, 2019

**NEW YORK, November 7, 2018**— The American Group Psychotherapy Association (AGPA) is coming to Los Angeles for its 2019 Annual Training, *AGPA Connect*, February 25 – March 2, at the Westin Bonaventure Hotel, Los Angeles, California. Entitled "Building Bridges of Connection through Group," this meeting attracts more than 1,000 group therapists, researchers and scientists from around the world.

Group therapists of all disciplines will gather to learn the most effective techniques in working with a variety of populations in groups, a valuable modality due to its effectiveness and cost-effectiveness. The theme reflects the meeting's emphasis on the power of groups to connect individuals, families and communities in meaningful ways to effect change on personal and societal levels.

- Marco Iacoboni, MD., Ph.D., will present the Mitchell Hochberg Memorial Public Education Event, Wednesday, February 27, entitled "Like a Thought That is Also a Feeling: The Betweenness of Empathy."
- Allan Schore, Ph.D. is presenting the Conference Opening Plenary on Thursday, February 28, entitled "Forging Connections in Group Psychotherapy Through Right Brain to Right Emotional Communications."
- Joyce Slochower, Ph.D., will deliver the annual Anne and Ramon Alonso Plenary Address, Friday, March 1 entitled, "Trying Not to Look Ahead."

## • Karen J. Maroda, Ph.D., ABPP will deliver the Louis R. Ormont Lecture on Saturday, March 2, "Countertransference, The Observing Ego, and Generative Communication: Ormont's Prescient Contributions to Contemporary Analysis."

This one-of-a-kind event, bringing together many of the nation's leading group therapists, will explore the variety of ways in which group therapy can help people and communities in today's world.
